

Group or Corporate Pension Schemes

This document is for Administrators, Trustees and Members of Group and Corporate Pension Schemes that transferred to Windsor Life from TomorrowTM at the end of December 2007. It explains the choice of funds available to members.

Why is the date a member joined the scheme important?

• Which funds a member can choose from depends on the date they joined the scheme.

What about increased (also called topped-up) benefits?

• If a member who joined **before** 1 January 2008 increases their benefits **after** 31 December 2007, their increase is treated slightly differently to their original benefits. The range of funds available for the increase is the same as for those who joined a scheme after 31 December 2007. (Please also see the point below about the unitised with-profits investment).

Unitised with-profits investment

 Unitised with-profits investment might be an available option in some cases where the member joined the scheme **before** 1 January 2008. If a member joined the scheme before that date and is interested in investing all or part of their increase on a unitised with-profits basis, please contact us and we will be able to advise whether it is available under the contract.

Fund Types

- Internal: ReAssure's investment managers (Aberdeen Asset Management) manage most of these funds.
- External funds: ReAssure does not manage these funds, but we have shown the name of the external fund manager.

Notes:

Internal Funds:

Fund charges are split into two categories, an explicit annual management charge is taken from the value of the fund and in addition, an implicit charge is incurred as the fund bears its own investment expenses. Any charges or expenses incurred in trading and administering the assets held within the funds are charged directly to the funds. Trading costs currently include such items as stamp duty and dealing commission, while administration costs primarily include investment management and custodial fees. We apply these charges to the funds as they occur.

External funds:

ReAssure does not accept responsibility for:

- the performance of the unit trust or open ended investment company (OEIC) represented by the external fund links, and
- any acts or omissions or other defaults of those involved in operating the unit trust or OEIC represented by the external funds.

The performance of external funds will not exactly mirror the performance of the underlying funds because of different fund charges and the timing of purchase and sale of units in the underlying funds.

Funds which invest wholly or partly in property:

If you invest in these funds it may not be possible to switch units or transfer your pension whenever you choose because property in the fund may not be readily saleable. In this situation ReAssure may temporarily refuse to switch units or pay a transfer value for up to six or twelve months depending on the fund. We would only do this where we believe this is in the interests of policyholders invested in that fund. The value of property is generally a matter of a valuer's opinion rather than fact.

All other funds:

ReAssure reserves the right to defer switching of units for up to three months where we think this is in the best interests of policyholders in general.
