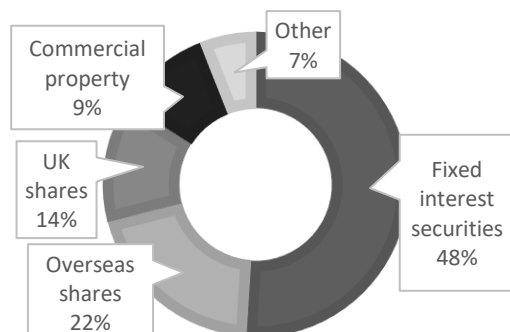


LG With-Profit Fund investment returns and asset mixes

- The pie chart shows the asset mix for the whole fund. The proportions of each type of asset we hold varies for groups of products.
- During 2023 we intend to develop further how we incorporate environmental, social and governance considerations into our investment decisions
- The tables below show the different asset mixes for different product groups. All asset mixes will vary over time as investment conditions and other factors influencing the appropriate mix for each product group change.
- Investment returns are calculated:
 - after deduction for investment expenses,
 - before tax is deducted for pensions, and after tax is deducted for life policies, and
 - rounded to one decimal place.
